

## **AGM DECEMBER 1<sup>ST</sup> 2021 ZOOM MTG. 7PM**

### **CARLETON PLACE & DISTRICT HORTICULTURAL SOCIETY**

**President Paul Pietsch** welcomed members to our Annual General Meeting.

There was a quorum of 24 members present. Dianne Elliott asked for motions to approve the Agenda: **Motion 1 – Laurie Graham 2 – Wanda Campbell.**

**TREASURERS REPORT** – Linda Bartlett gave a summary of our financials and mentioned that it was agreed by the Financial Reviewers that the Assets portion of the report was not applicable as all our assets were not financially feasible.
